# Honors & Recognition Update

Mr. Esposito reported to the Board about a new process regarding awards and honors announcements:

During its 8 February 2023 meeting, the Executive Committee accepted the suggestion that, going forward, the STC VP will be responsible for managing responsibilities related to announcing awardees and honorees. Specifically, the VP will:

- 1. Coordinate with committee chairs to ensure the winners are announced in official STC channels.
- 2. Ensure that headshots, bios, citations, translations, and so on for the Honors event and other communications of the winners are collected and provided to the right people.
- 3. Oversee the entire production for the Honors event, to include ensuring award plaques, brochures, slides, scripts, and so on are prepared and provided to the right people before the ceremony.

To that end, Mr. Esposito is creating a spreadsheet that will be a master list of all awards, awardees, citations, blog entries, photos (when applicable), website updates, and so on, that can be used as a source for the Honors pamphlet. He hopes to set it up this weekend, but will notify the BoD when it's set up.

After this is set up, Mr. Esposito will ask each liaison to work with their award committee chairs to collect all the information needed for each award. The liaison will then provide Mr. Esposito with the info in one, concise collection of content, for easy processing so he can post things accordingly.

The process will be that the Vice President hears only from the liaisons, and only with complete information on each award.
